Multi Purpose

Category 3A

- Hand held hoses fitted with a trigger nozzle at any time.
- Automated watering systems that sense soil moisture can be used at any time.
- Sprinklers and watering systems before 10 am and after 4 pm for a maximum duration of 2 hours/day.

Category 1B

- Hose fitted with a trigger nozzle or high-pressure cleaning equipment with a maximum flow rate of 20litres per minute. (including windows, walls, gutters, roofing and paved areas).

Category 3C

- Sprinklers and watering systems before 10am and after 4pm on **Active playing Surfaces Only**.
- Automated watering systems with controllers that automatically adjust to weather or soil moisture conditions can be used at any time.

Hoses fitted with a trigger nozzle or high-pressure cleaning equipment with a maximum flow rate of 20 litres per minute for the reasonable purposes of health, safety and hygiene are permitted.

This letter is your Exemption Permit under Level 1 Water Restrictions. It defines the conditions under which you may use water outdoors for specific activities and is enforceable by Sydney Water. It is a condition of your exemption approval that Sydney Water

may, at any time within your normal working hours, conduct audits of your compliance with the conditions of the permit. You may be liable for fines or cancellation of your exemption for breaches of your exemption conditions.

You must be able to produce this letter to an authorised Sydney Water officer on request as proof of your exemption.

We will provide an exemption sticker that you can display to inform members of the public that you have an exemption to use water in specific ways as listed in this permit. Exemption stickers are designed to be attached to external surfaces and are weather resistant.

This exemption letter covers University of New South Wales, any subcontractors with an ABN different to that of the university will need to apply for a separate exemption.
